THE MARK CONSISTS OF TWO LETTER "ES", ONE ON THE LEFT THAT IS FORWARDS AND ONE ON THE RIGHT THAT IS BACKWARDS, THE LETTERS BEING VARYING SHADES OF GREEN ON A WHITE BACKGROUND, THE LETTERS BEING SHADED SO THAT A LIGHT APPEARS TO BE SHINING ON THEM FROM THE LOWER LEFT, THE LETTERS HAVING ONLY CORNERS WITH RIGHT ANGLES, EXCEPT WHERE A DIAGONAL SPACE SEPARATES THE LETTERS, WITH THE DIAGONAL SPACE AND THE SPACES WITHIN THE LETTERS APPEARING TO FORM THE NOT EQUAL SIGN IN MATHEMATICS, AND WITH THE LETTERS APPEARING TO HAVE FLAT RAISED SURFACES WITH SLOPING EDGES.
